

All the models (indoor unit) list in this test report were alternative two kinds of wireless modules (type: MK-QTWIFI-08 and HEWRQU1) with USB WIFI Dongle and plug it out of the air conditioner, one kind of wireless modules (type: ESP32-for-Haier) with PCB Antenna and plug it out of the air conditioner have been verified in the test report Number of 64.920.19.06297.01R, 4842020233500B and SHEM200500402604. These hosts which installed the wireless module are equivalent, and installed according to the installing instruction. So there are no additional test for new combined products. The test data and results refer to test report Number of 64.920.19.06297.01R, 4842020233500B and SHEM200500402604.
